#### **ATTENDANCE**

The City Council of Columbus, Kansas met December 19, 2016 at 6:30 p.m. in the City Hall Council Chambers presided over by Mayor W.E. Schaiff. Council members present: Connie Bennett, Jerri Burton, Steve Dunlap, Ron Johnson, James Lucian, Sammye Opela, John Paradee, Drew Richards, Grant Spieth. Council members absent: Alvin Patterson.

Pastor Randy Arnold of Victory Life Church led the Invocation followed by the Pledge of Allegiance.

# **CONSENT AGENDA**

Burton moved to approve the consent agenda consisting of December 5, 2016 council meeting minutes and appropriations ordinance 16-422 as presented. Richards seconded the motion. Voting aye: Bennett, Burton, Dunlap, Johnson, Lucian, Opela, Paradee, Richards, Spieth. Voting nay: None. Motion carried 9-0.

# **VISITOR** – *ROBIN WELLS*

Robin Wells representing Columbus Recreation Commission provided information regarding the opportunity of a recreation center at the old Pamida building. Wells stated the building has been purchased by Community Health Center of Southeast Kansas (CHCSEK) however they will only be utilizing a portion of the facility and are open to the idea of leasing the additional space. Wells believes a recreation center is possible even with the smaller available area. Council members had questions including but not limited to renovation costs, equipment costs, insurance, staffing and memberships. Wells will provide new numbers and plans.

Discussion also covered soccer field, Crossland Park and skate park plans.

#### RECREATION CENTER

Council voted to give a two month extension with update at the December 19 council meeting. Mrs. Caton stated B3 will be taking down the structure however she does not have a definite date, it will depend on their schedule and the weather.
