The City Council of Columbus, Kansas, met July 21, 2014 at 6:30 p.m. in the City Hall, presided over by Mayor Grant Spieth. Council members present: Dale Burton, Jerri Burton, Barbara Capron, Mike Leighty, Marion Morgan, Thomas Niegisch, Alvin Patterson, Drew Richards, Dewey Smith, Gary Smith. Council member absent: None.

Reverend Roger Beason led the Invocation followed by the Pledge of Allegiance.

PUBLIC HEARING - The Cave- Wavier on Cereal Malt Beverage License

Mayor Grant Spieth opened the public hearing meeting at 6:34 p.m.

Meeting was begun by Mayor reading Public Hearing Notice:

The governing body of the City of Columbus, Kansas has called a public hearing to consider the request for granting a wavier and exception to the code of the City of Columbus, Section 3-206: Restrictions upon location, on behalf of The Cave regarding sale and consumption of cereal malt beverages.

Mayor Spieth asked if Ms. Turner (owner/operator of the establishment) was present. Ms. Turner approached the podium. Mayor Spieth clarified that she is requesting a variance for her business location of 218 East Maple. He asked if there was anything else she would like to address the council about. Ms. Turner stated that the age requirement of servers was noted elsewhere on the agenda and that was her other concern.

Mayor Spieth asked Police Chief Jason Daniels what the measurements were from the building to the church. Attorney Robert Myers responded that he and City Superintendent Jim Burton had measured and it was within the 200 feet. Mayor Spieth clarified that the distance was less than 200 feet and the Attorney response was less than 200 feet. The Mayor stated with this information an exemption would have to be made to allow this type of business to be located there

Mayor asked if Ms. Turner had any questions or comments. She had none.

Mayor then turned to the council and asked for questions. Councilman Leighty asked if the measurement was property line to property line. Attorney Myers replied that it was.

Mayor asked for any opposition from the public or if anyone wished to address the council regarding the variance. There were no replies.

Attorney Myers informed council members they have a copy of an ordinance in their packet that grants an exception for the address of 218 East Maple for The Cave and if approved it would be Ordinance 1329.
