#### **ATTENDANCE**

The City Council of Columbus, Kansas met July 06, 2015 at 6:30 p.m. in the City Hall Council Chambers presided over by Mayor Dexter Opela. Council members present: Dale Burton, Jerri Burton, Barbara Capron, Steve Dunlap, Mike Leighty, David Martin, Marion Morgan, Alvin Patterson and Drew Richards. Council members absent: W.E. Schaiff.

Council member Alvin Patterson led the Invocation followed by the Pledge of Allegiance.

## **MEETING MINUTES**

Burton Jerri moved to approve Council Meeting minutes from June 15, 2015 as presented. Burton Dale seconded the motion. Voting aye: Burton Dale, Burton Jerri, Capron, Dunlap, Leighty, Martin, Morgan, Patterson, Richards. Voting nay: None. Motion carried 9-0.

## **APPROPRIATION ORDINANCE 15-384**

Burton Dale moved to approve Appropriation Ordinance 15-384 as presented. Leighty seconded the motion. Voting aye: Burton Dale, Burton Jerri, Capron, Dunlap, Leighty, Martin, Morgan, Patterson, Richards. Voting nay: None. Motion carried 9-0.

#### **VISITOR – Rick Ensz**

Rick Ensz of Cooper Malone McClain Inc. reviewed bond disclosure regulations with the City Council members and staff. Mr. Ensz reported the City is behind in the reporting process and the advised them of the steps needed to bring the City into compliance. Mr. Ensz stated his company could process the bond disclosures and the failure to file paperwork for \$2,500.00.

## **VISITOR – Chris McGowan**
