COUNCIL MEETING MINUTES

Burton Jerri moved to approve Council Meeting minutes from June 2, 2014 as written. Capron seconded the motion. Voting aye: Burton Dale, Burton Jerri, Capron, Leighty, Morgan, Patterson, Smith Dewey, Smith Gary. Voting nay: None. Abstain: Niegisch. Motion carried 8-0-1.

APPROPRIATION ORDINANCE 14-355

VISITOR - RICK ENSZ

VISITORS – MIKE AND JANELLE BOWMAN

The Bowman's approached the council with information on the refurbishing of the Old State Theatre. The Bowman's envision turning this property into a venue for weddings and events. They are seeking a \$20,000.00 grant/donation from the City along with consideration for tax abatement. Additional sources of funding and resources were discussed.
