#### **ATTENDANCE**

The City Council of Columbus, Kansas met March 6, 2017 at 6:30 p.m. in the City Hall Council Chambers presided over by Mayor W.E. Schaiff. ## **CONSENT AGENDA**

Burton moved to approve the consent agenda consisting of February 21, 2017 council meeting minutes and Appropriation Ordinance 17-431 as presented. Paradee seconded the motion.
