## **ATTENDANCE**

The City Council of Columbus, Kansas met May 16, 2016 at 6:30 p.m. in the City Hall Council Chambers presided over by Mayor Dexter Opela. ## **MEETING MINUTES**

## VISITOR – ROBIN WELLS/DAVID CARRIGER

Robin Wells and David Carriger representing Columbus Recreation Commission approached the council with idea of turning the old Pamida building on South East Avenue into a recreation center for the City. Carriger stated the Columbus Community Foundation would be willing to acquire the building and donate it to the City for this purpose. Wells provided diagrams and program possibilities for the facility as well as potential income projections. Carriger noted they would be in contact with the owner of the building again on June 15 and would need an answer before then whether or not the council would be interested in pursuing this project. Mayor Opela offered the Property, Pool and Parks committee could have a meeting and review the feasibility and report back to the full council for consideration at the June 6 council meeting.

## **VISITOR** – *LARRY ZAHM*

Larry Zahm owner of old Bulldog Building Company property located at 130 South Kansas approached the council asking for clarification regarding what needed to be addressed or fixed to bring the building into safety compliance. Pictures of the structure were reviewed, structural integrity of the south side and points of concern were noted. Mr. Zahm thanked the council for their time and suggestions and noted he would address this to see what he can get done.

### **VISITOR** – *LAURA LOWERY GREENE*

Laura Lowery Greene co-owner of Maple UnCommon Hotel approached the council with request to revise the details of her Rehabilitation Grant awarded November 2015. Unforeseen events have caused her to revisit the plans for the building. Mrs. Greene still would like to take advantage of the matching funds but will be looking at rebranding and marketing opportunities instead of cosmetic changes to the structure. Mrs. Greene also noted the facility will be celebrating its ten year anniversary this November.

Schaiff moved to approve the changes to the Rehabilitation Grant for Maple UnCommon. Richards seconded the motion. Motion and second rescinded before a vote. Mrs. Greene will provide two bids and new renderings/plan for council consideration.
