ORDINANCE NO. 1218

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF COLUMBUS, KANSAS, ANNEXING CERTAIN LAND TO THE CITY OF COLUMBUS IN CONFORMITY WITH THE PROVISIONS OF K.S.A. 12-520, AS AMENDED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS.

SECTION 1: The following described real estate, located on East Merle Evans Drive, Columbus, Cherokee County, Kansas, to-wit:

A portion of Government Lot 4, being a portion of the Southwest Quarter of the Southwest Quarter of Section 18, Township 33 South, Range 24 East of the 6<sup>th</sup> Principal Meridian, Cherokee County, Kansas, more particularly described as follows:

Commencing at the Northwest corner of the Southwest Quarter of the Southwest Quarter of Section 18, Township 33 South, Range 24 East of the 6<sup>th</sup> Principal Meridian; thence with a bearing of record North 89°56'50" East along the North line of the Southwest Quarter of said Northwest Quarter 60.50 feet to the East Right-of-Way line of U.S. Highway 69, for the point of beginning, said point being the Northwest Corner of Columbus Industrial Park Addition to the City of Columbus, Kansas; thence continuing North 89°56'50" East along the North line of Columbus Industrial Park Addition 1218.50 feet (1218.24 feet platted) to the Northeast Corner of said addition; thence South 00°28'28" East along the East line of said addition 85.26 feet (85.00 feet platted) to the Northeast Corner of Lot 4 of said addition; thence South 88°32'40" West along the North line of Lots 1,2,3 and 4 of said addition 1219.16 feet (1218.24 feet platted) to the Northwest Corner of Lot 1 of said addition; thence North 00°28'30" West along the West line of said addition 53.17 feet (50.00 feet platted) to the point of beginning containing 1.936 Acres subject to any easements of record.

Subject to all easements, restrictions, reservations and covenants, if any, now of record.

meeting one or more of the classifications for annexation prescribed by K.S.A. 12-520, is hereby annexed and made a part of the City of Columbus, Kansas.

SECTION 2: That this Ordinance shall take effect and be in force from and after its passage, approval and publication in the official City newspaper.
