ORDINANCE NO. 1262

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF COLUMBUS, KANSAS, ANNEXING CERTAIN LAND TO THE CITY OF COLUMBUS IN CONFORMITY WITH THE PROVISIONS OF K.S.A. 12-520, AS AMENDED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS.

SECTION 1: The following described real estate, situate at Columbus, Cherokee County, Kansas, to-wit:

A portion of the Northeast Quarter (NE/4) of Section Fourteen (14), Township Thirty-three (33) South, Range Twenty-three (23) East of the Sixth Principal Meridian, Cherokee County, Kansas, according to the United States Government Survey thereof, bounded and described as follows: Beginning at a point on the North line of said Northeast Quarter (NE/4), said point being a distance of One thousand three hundred nine and sixty hundredths (1309.60) feet North Ninety (90) degrees Zero (00) minutes Zero (00) seconds West of the Northeast corner of the Northeast Quarter (NE/4); thence on a bearing of South Three (03) degrees Fifty-four (54) minutes Ten (10) seconds West a distance of Five hundred seventy-three and thirty-three hundredths (573.33) feet to the North right of way line of the St. Louis and San Francisco Railroad; thence on a bearing of North Seventy-six (76) degrees Fifty-four (54) minutes Twenty-three (23) seconds West along said right of way line a distance of Four hundred seventy-four and eighty-two hundredths (474.82) feet; thence on a bearing of North Zero (00) degrees Zero (00) minutes Zero (00) seconds East a distance of Four hundred sixty-four and forty-four hundredths (464.44) feet to said North line; thence on a bearing of South Ninety (90) degrees Zero (00) minutes Zero (00) seconds East along said North line a distance of Five hundred one and fifty hundredths (501.50) feet to the point of beginning.

Subject to all easements, restrictions, reservations and covenants, if any, now of record, meeting one or more of the classifications for annexation prescribed by K.S.A. 12-520, is hereby annexed and made a part of the City of Columbus, Kansas, at the request and with the express consent of The Coffeyville Community College Foundation.

SECTION 2: That this Ordinance shall take effect and be in force from and after its passage, approval and publication in the official City newspaper.
