AN ORDINANCE VACATING THE ALLEYS LYING BETWEEN NORTH FLORIDA AVENUE AND NORTH VERMONT AVENUE AND WEST LAKES STREET AND WEST CEDAR STREET OF THE CITY OF COLUMBUS, KANSAS AND REPEALING ANY ORDINANCE IN CONFLICT THEREWITH.

**BE IT ORDAINED BY THE GOVERNING BODY OF
THE CITY OF COLUMBUS, KANSAS:**


SECTION 1. The alleys running north and south and lying between W. Cedar St. and W. Lake St. and running East and West and lying between N. Florida Ave. and N. Vermont Ave. is hereby vacated in accordance with the provisions of K.S.A. 14-423.

SECTION 2: The City of Columbus retains utility easements over, under, or along said vacated alley.

SECTION 3. All ordinances and resolution and parts thereof in conflict herewith are hereby expressly repealed in so far as they conflict herewith.

SECTION 4: This ordinance shall take effect thirty (30) days after first publication in the official city newspaper unless a written protest is filed in the office of the City Clerk.

ORDINANCE NO. 1333

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF COLUMBUS, KANSAS,
GRANTING A WAIVER AND EXCEPTION TO THE CODE OF THE CITY OF
COLUMBUS, SECTION 3-206, *RESTRICTIONS UPON LOCATION*, ON BEHALF OF
LOS LUNAS MEXICAN RESTAURANT, INC. REGARDING SALE AND
CONSUMPTION OF CEREAL MALT BEVERAGES.

**BE IT ORDAINED BY THE GOVERNING BODY OF
THE CITY OF COLUMBUS, KANSAS:**

SECTION I: Pursuant to City Code Section 3-206, sale of cereal malt beverage is restricted by location and not permitted within 200 feet from any church, school, nursing home, library, hospital or park.


SECTION II: Elizabeth Luna, representing Los Lunas Mexican Restaurant, Inc., doing business at 114 S. Kansas, Columbus, Kansas, has petitioned the City seeking a waiver from the above-referenced Code which restricts the location of the sale and consumption of alcoholic beverage, specifically, cereal malt beverage.

SECTION III: The City Council hereby grants a waiver and exception to the restriction on location to permit the sale and consumption of cereal malt beverage only to Los Lunas Mexican Restaurant, Inc., doing business at 114 S. Kansas, Columbus, Kansas, subject to all State and local license requirements.

SECTION IV: All ordinances, resolutions or policies or parts thereof in conflict herewith are hereby expressly repealed insofar as they conflict herewith.
