

ORDINANCE NO. 1334

AN ORDINANCE REPEALING CHAPTER VI, ARTICLE 2 OF THE CODE OF THE CITY OF COLUMBUS, KANSAS AND PROVIDING SUBSTITUTE PROVISIONS THEREOF.

**BE IT ORDAINED BY THE GOVERNING BODY OF
THE CITY OF COLUMBUS, KANSAS:**

SECTION 1. That Chapter VI, Article 2 of the Code of the City of Columbus, Kansas is hereby repealed.


SECTION 2. The new Chapter VI, Article 2 of the Code of the City of Columbus, Kansas shall read as follows:

ARTICLE 2. WARDS

- 6-201. **FIRST WARD.** The first ward of the city shall consist of all that part or portion of the city now or hereafter lying and situated north of the center line of Maple Street and West of the center line of North Railroad to East Buckeye to the center line of North Ohio extended, and East of the center line of North High School, and the center line of North High School extended, and including also all that portion of the R.L. Hayes addition to the city lying west of the center line of North High School in the center line of North High School extended, excluding the block West Walnut to Maple between North High School and North Vermont, which is designated in Ward 2.
- 6-202. **SECOND WARD.** The second ward of the city shall consist of all that part or portion of the city now or hereafter lying and situated north of the center line of Maple Street, and west of the center line of North High School extended and shall include the block between West Walnut and Maple and between North High School and North Vermont, except that portion of the R.L. Hayes Addition to the city lying west of the center line of North High School in the centerline of North high school extended.
- 6-203. **THIRD WARD.** The third ward of the city shall consist of all that part or portion of the city now or hereafter lying and situated south of the center line of Maple Street and West of the center line of South Vermont to west Country Rd. to South Minnesota and South Minnesota extended.
- 6-204. **FOURTH WARD.** The fourth ward of the city shall consist of all that part or portion of the city now or hereafter lying and situated south of the center line of Maple Street, and East of the centerline of South Vermont to West Country Rd. to South Minnesota extended, and West of the center line of Tennessee Avenue to West Country Rd. to South Park Dr. extended.
- 6-205. **FIFTH WARD.** The fifth ward of the city shall consist of all that part or portion of the city now or hereafter lying and situated east of the center line, beginning at North Railroad and Maple Street heading north to East Buckeye, then east to North Ohio and the center line of North Ohio extended and situated east of the center line, beginning at South Railroad and Maple Street heading south of the center line of South Railroad extended.

SECTION 3: This ordinance shall take effect after publication in the official city newspaper and according to the dates established herein.
