RESOLUTION NO. 140

A RESOLUTION CORRECTING COUNCIL ACTION
OF MAY 9, 1988, BY SPECIFYING AND LISTING
PROPERTY TO BE EXEMPTED FROM AD VALOREM TAXATION
FOR ECONOMIC DEVELOPMENT PURPOSES FOR CALIBRATED FORMS, CO.

WHEREAS, the City Council of Columbus, Kansas met in Special Session on May 9, 1988, and among other things granted an ad valorem tax exemption to Calibrated Forms, Co., for for a period of ten (10) years on real estate and an ad valorem tax exemption for a period of Seven (7) years on personal property, for economic development reasons; and

WHEREAS, partially through error and inadvertence and because the exact description of the property to be exempted from taxation was unknown, the description of the properties were not set forth therein; and

WHEREAS, this oversight has been called to the attention of the Governing Body of the City of Columbus, Kansas, and it is the intention of the Governing Body that such error and inadvertence be herewith corrected.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS, that in accordance with Section 13 of Article 11 of the Kansas Constitution, the following property, commonly referred to as Calibrated Forms, Co. property, is hereby exempt from ad valorem taxation for a term of Ten (10) calendar years from the date of its acquisition:

- A. REAL ESTATE ACQUIRED 1988: Commencing 110 Feet North of the Southwest Corner of Lot Two (2), in Block One (1), in Park Addition to the City of Columbus, according to the recorded plat thereof, thence North 60 Feet, thence East 351 Feet, thence South 60 Feet, thence West 351 Feet to beginning; Cost \$ 14,540.00.
- b. Real Estate Improvements:
 - 1988, Building Addition #1, driveway, storage on deck, padder, overhead door, fence. Cost \$ 9,981.79.

- ii. 1988, Shipping Building Addition. Cost \$ 106,080.00.
- iii. 1989, Main Building Expansion.
 Cost \$ 65,930.00.

BE IT FURTHER RESOLVED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS, that in accordance with Section 13 of Article 11 of the Kansas Constitution the following property, commonly referred to as Calibrated Forms, Co. property, is hereby exempt from ad valorem taxation for a term of Seven (7) calendar years from the date of its acquisition:
