## **RESOLUTION NO. 261**

A RESOLUTION APPROVING A MODIFICATION OF PROJECT SCOPE AND ASSURING AND CERTIFYING TO THE KANSAS DEPARTMENT OF COMMERCE AND HOUSING THAT ALL NON-CDBG FUNDS REQUIRED TO COMPLETE THE WATER DISTRIBUTION/DRAINAGE PROJECT ARE OBLIGATED ON A CONDITIONAL BASIS AS REQUIRED BY THE 1997 SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM AND SEEKING AN EXTENSION OF THE GRANT FOR A TERM TO COMPLETE CONSTRUCTION OF THE PROJECT

WHEREAS, the City of Columbus has made application to the Kansas Department of Commerce and Housing (KDOC&H) for Community Development Block Grant (CDBG) funds for a major water drainage project within the Columbus city limits; and

WHEREAS, the grant application was approved by the KDOC&H and designated at CDBG #97-PF-101 awarding \$224,986 of grant funds to the drainage project with the City matching funds at a similar amount; and

WHEREAS, further consideration and engineering by the City determined the initial project scope should be expanded to include a lengthier portion of the drainage corridor to protect additional impacted private and public properties; and

WHEREAS, the City has delayed construction of the project to await engineering specifications and cost estimations of an expanded drainage project; and

WHEREAS, the City considers the project and use of public funds best serves the public in an expanded scope to include the storm water drainage corridor between Maple Street and Park Street; and

WHEREAS, the cost of the approved, expanded project is estimated at \$691,911 to be cost shared \$224,986 of CDBG funds and \$466,925 provided by the City;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Columbus, Kansas the following:

Section 1. That the Governing Body of the City of Columbus hereby certifies to the Kansas Department of Commerce and Housing that it will obligate \$466,925 of City funds as the City's matching funds for the expanded storm water drainage system improvements as delineated in the Project Scope Revision request to be submitted to the Kansas Department of Commerce and Housing and as detailed in the amended project budget:

Section 2. That the Mayor is authorized to seek a change of project scope for the previously-awarded Community Development Block Grant #97-PF-101 to include the expanded storm water drainage corridor from Maple Street to Park Street;

Section 3. That the Mayor is authorized to submit a request to the Kansas Department of Commerce & Housing for a grant extension of Community Development Block Grant #97-PF-101.
