That the CITY hereby approves the Amendment to Agreement to Organize Public Wholesale Water Supply District No. 11 and the CITY hereby authorizes its Mayor and City Clerk to sign said Amendment to include Consolidated Rural Water District No. 1, Crawford County, Kansas, as a member of Public Wholesale Water Supply District No. 11, State of Kansas.
