RESOLUTION NO. 348

A RESOLUTION FINDING THAT THE STRUCTURE LOCATED AT

425 N. Magnolia Avenue, BG-C, Columbus, Cherokee County, Kansas, consisting of:

Section 13, Township 33, Range 23, Beg 176 N & 115 W SE COR NW4 NE4 TH S7 W83 S11 W110 to E LN RR R/W NLY 98 M/L to S LN RR R/W NELY 194 S to POB,

IN THE CITY OF COLUMBUS, CHEROKEE COUNTY, KANSAS, IS UNSAFE AND DANGEROUS, AND DIRECTING THAT THE STRUCTURES BE REMOVED AND THE PREMISES MADE SAFE AND SECURE.

WHEREAS, the Enforcing Officer of the City of Columbus, Kansas, did on the 3rd day of January, 2007, file with the governing body of said City a statement in writing that a certain structures, described above, were unsafe and dangerous; and,

WHEREAS, the Governing Body did by Resolution No. 345, dated the 3rd day of January, 2007, fix the time and place of a hearing at which the owner, his agent, and lienholders, any occupants and all other parties of interest of such structure could appear and show cause why such structure should not be condemned and ordered demolished and provided for giving notice thereof as provided by law; and,

WHEREAS, Resolution No. 345 was published on the 8th day of January, 2007, and on the 15th day of January, 2007, and a copy of said resolution was served upon all persons entitled thereto as provided by law; and,

WHEREAS, on this 20th day of February, 2007, the governing body did conduct the hearing scheduled in Resolution No. 345 and took evidence from the following: Larry Overman, property owner, and Charles Sharp, the Enforcing Officer on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS, THAT:

1. The Governing Body hereby finds that the structures and debris located at:

Section 13, Township 33, Range 23, Beg 176 N & 115 W SE COR NW4 NE4 TH S7 W83 S11 W110 to E LN RR R/W NLY 98 M/L to S LN RR R/W NELY 194 S to POB, in the City of Columbus, Cherokee County, Kansas, and commonly referred to as 425 N. Magnolia Avenue, BG-C, Columbus,

Kansas, are unsafe and dangerous and directs that such structures and debris are to be removed and the premises made safe and secure.

- 2. The owner of such structure is hereby directed to commence the removal of the structures and debris within thirty (30) days from the date of publication of this Resolution, and not later than April 10, 2007, and to complete the removal of the structure not later than April 10, 2007.
- 3. If the owner fails to complete the removal of the structure within the time stated herein, or any additional time granted by the Governing Body, or fails to diligently prosecute the same until the work is completed, the Governing Body will cause the structure to be razed and removed and the costs of razing and removing, less salvage, if any, shall be collected in the manner provided by K.S.A. 12-1,1115, and amendments thereto, or shall be assessed as a special assessment against the lot or parcel of land upon which the structure is located or by both, all as provided by law.

BE IT FURTHER RESOLVED, that if the owner fails to commence the removal of the structure within the time provided herein or fails to diligently prosecute the same, the Governing Body may take such further action as it deems necessary to raze and remove the structure without further notice to the owner or other parties in interest.

BE IT FURTHER RESOLVED, that the City Clerk shall cause this Resolution to be published once in the official City paper and mail a copy to the owners, agents, lienholders, occupants and other parties in interest.
