DEDICATION OF MERLE EVANS DRIVE AS PUBLIC STREET AND ROADWAY AND FOR PUBLIC UTILITY PURPOSES

The City Council of the City of Columbus, Kansas, does hereby amend its original plat of the Columbus Industrial Park Addition, and hereby dedicates and conveys to the public a right-of-way and easement for public street and roadway purposes and for public utility purposes, and to the following described real estate, known as Merle Evans Drive, located in Columbus.
