That a hearing will be held on the 7th day of July, 2008, before the Governing Body of the City at 7:30 o'clock p.m., at Columbus City Hall Council Chambers, 300 East Maple, Columbus, Kansas 66725, at which the owner, his or her agent, any lienholders of record, any occupant and any other parties in interest, as that term is defined by law, of the structures located at:

535 W. Mulberry Street, Columbus, Cherokee County, Kansas, consisting of Block 2 in Henderson's Addition, described as:

E/2 LTS 9-10; E/2 S/2 LT 11 EXC W10

may appear and show cause why such structures should not be condemned as unsafe or dangerous structures and ordered repaired or demolished and the debris removed.

BE IT FURTHER RESOLVED, that the City Clerk shall cause this resolution to be published and shall give notice of the aforesaid hearing in the manner provided by law.
