

RESOLUTION NO. 512

**A RESOLUTION FINDING THAT THE STRUCTURE LOCATED AT 608 NORTH HIGH SCHOOL AVENUE, COLUMBUS, CHEROKEE COUNTY, KANSAS, PARCEL NUMBER 011-136-13-0-20-04-013.00-0, Described as S13, T33, R23, Beg 607.5 S of NW Cor, Th E 238.5, S150, W238.5, N150 to POB EXC ROW, COLUMBUS, KANSAS, IS UNSAFE AND DANGEROUS, AND DIRECTING THAT THE STRUCTURE BE REMOVED AND THE PREMISES MADE SAFE AND SECURE.**

**WHEREAS, the Enforcing Officer of the City of Columbus, Kansas, did on the 20<sup>th</sup> day of March, 2017, file with the Governing Body of Columbus, Kansas, a statement in writing that a certain brown, two-story residential structure, herein described, is dilapidated, unsafe and dangerous and a blight upon the neighborhood; and,**

**WHEREAS, the Governing Body the time and place of a hearing at which the owner, her agent, and lienholders, any occupants and all other parties of interest of such structure could appear and show cause why such structure should not be condemned and ordered demolished and provided for giving notice thereof as provided by law; and,**

**WHEREAS, Resolution No. 506 was published on the 9<sup>th</sup> day of June, 2017, and on the 16<sup>th</sup> day of June, 2017, and a copy of said resolution was served upon all persons entitled thereto as provided by law; and,**

**WHEREAS, on the 17<sup>th</sup> day of July, 2017, the governing body did conduct the hearing scheduled in Resolution No. 506 and took evidence from the following; the Enforcing Officer on behalf of the City.**

**The owner(s) of such structure is/are hereby directed to commence the removal of the structure within fourteen days (14) days from the date of this hearing, not later than July 31, 2017, and to complete the removal of the structure not later than August 17, 2017.**

**If the owner(s) fail(s) to complete the removal of the structure within the time stated herein, or any additional time granted by the Governing Body, or fails to diligently prosecute the same until the work is completed, the Governing Body will cause the structure to be razed and removed and the costs of razing and removing, less salvage, if any, shall be collected in the manner provided by K.S.A. 12-1,1115, and amendments thereto, or shall be assessed as a special assessment against the lot or parcel of land upon which the structure is located or by both, all as provided by law.**

**BE IT FURTHER RESOLVED, that if the owner fails to commence the removal of the structure within the time provided herein or fails to diligently prosecute the same, the**

Governing Body may take such further action as it deems necessary to raze and remove the structure.

BE IT FURTHER RESOLVED, that the City Clerk shall cause this Resolution to be published once in the official City paper and mail a copy to the owners, agents, lienholders, occupants and other parties in interest.
