The City Council of Columbus, Kansas met July 02, 2018 at 6:30 p.m. in the City Hall Council Chambers presided over by Mayor Grant Spieth. CONSENT AGENDA

Burton moved to approve the consent agenda consisting of June 18, 2018 council meeting minutes and Appropriation Ordinance 18-467 as presented. Paradee seconded the motion. City Treasurer Report -

-Interest income up \$30,000 from same period last year.

City Superintendent Report -

- -Pump motor problems at the pool, ordered new one, it was damaged by trucking company during transit. Hope to have replacement by Friday. Pool is open, motor could go out again at any time.
- -Have found out that Purple Wave Auction will not allow reserve/minimum bid on fire prevention trailer listing.
- -CDL will begin work as early as Friday on cemetery water line. Boring project will cost \$2,150; there will be additional cost if they hit rock.
- -Crews getting the City ready for the Fourth of July events.
