**ORDINANCE NO. 1446**

**AN ORDINANCE OFFICIALLY NAMING THE CITY PARK AT 71 SOUTHWEST TWENTIETH (20TH) STREET, COLUMBUS, KANSAS, SITUATED IN THE CROSSLAND LAKEWOOD WEST SUBDIVISION, LYING ADJACENT TO AND NORTH OF CROSSLAND LANE, AND ADJACENT TO AND EAST OF SOUTHWEST TWENTIETH (20TH) STREET.  
THE PARK SHALL BE NAMED "EDDINGTON PARK"**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS:**

**WHEREAS**, the City of Columbus, Kansas, controls and manages its City parks for the use and benefit of the people.

**WHEREAS**, the City park located at 71 Southwest Twentieth (20th) Street, Columbus, Kansas, is being developed as a recreational facility for multiple recreational uses to benefit the people.

**WHEREAS**, in recognition of the Eddington family's years of volunteering and contributing to the community, the Governing Body officially designates and names the City park located at 71 Southwest Twentieth (20th) Street, Columbus, Kansas, "Eddington Park."

**SECTION 1.** K.S.A. 12-101 *et. seq.*, and the Kansas Constitution authorize the Governing Body of the City of Columbus, Kansas, to transact all City business and perform all powers of local legislation deemed appropriate, and to make all contracts and do all other acts in relation to the property and concerns of the city necessary to the exercise of its corporate or administrative powers.

**SECTION 2.** Pursuant to its statutory authority, the Governing Body of the City of Columbus, Kansas, hereby names the City park, located at 71 Southwest Twentieth (20th) Street, Columbus, Kansas, "Eddington Park," described as follows:

**SECTION 3.** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.


**SECTION 4.** This Ordinance shall take effect and be in force upon passage and shall be

published in the official City newspaper.
