ORDINANCE NO. 1463

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF COLUMBUS, KANSAS, ADJUSTING WASTEWATER SYSTEM RATES CHARGED EACH CUSTOMER IN THE CITY OF COLUMBUS, KANSAS, AND REPEALING ANY ORDINANCE OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS.

SECTION 1: Ordinance 1324 shall be repealed.

SECTION 2: Beginning May 1, 2020, the rates to be charged for wastewater disposal service furnished by the wastewater system of the City of Columbus, Kansas, shall be as follows:

- a. A minimum charge of **\$16.56** shall be made for each water meter within the corporate limits of the City of Columbus, Kansas. This charge includes 2000 gallons of wastewater.
- b. For wastewater over 2000 gallons, the charge shall be **\$4.46** per thousand gallons.
- c. The minimum wastewater charge and wastewater usage charges for customers shall increase 3% annually, beginning January 1, 2021.

SECTION 3: All ordinances and resolutions and parts thereof in conflict herewith are hereby expressly repealed in so far as they conflict herewith.

SECTION 4: This ordinance shall be in full force and effect from and after passage and publication in the official City newspaper.

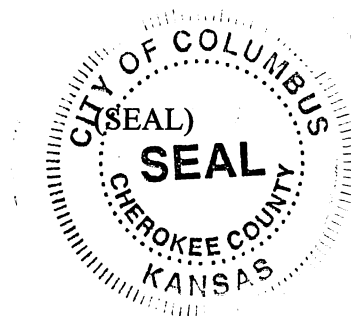

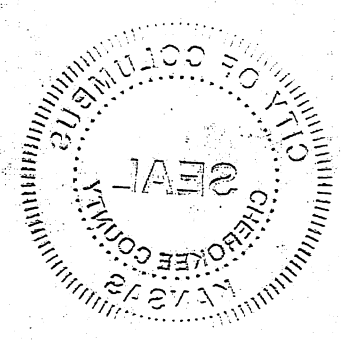
