City Clerk Report -

Police Chief Report –

- -Conducted interviews for the open Animal Control Officer position. An offer was made to one of the candidates, hopeful to have them on board by the first of November.

HIRE PROPERTY & PARKS DIRECTOR – Randy Coble

Opela moved to approve Randy Coble for the FLSA exempt position of Property & Parks Director at an annual salary of \$43,000 providing he passes all pre-employment requirements. 1. *Discuss Fire Service billing*. Several items of concern were discussed. Fire Chief Steven Burton noted the intent is not to go after uninsured people. Burton informed that he would be in charge of submitting claims to the collection agency. He also noted that the company can be instructed not to proceed with a claim in the event it is denied by the insurance company. Houser moved to have the City Attorney provide draft ordinance for review at the next council meeting to update the current City Code to utilize fire rescue billing. Doherty seconded the motion. Voting aye: Bennett, Brassart, Burton, Doherty, Gilmore, Houser, Long, Opela, Pryor. Voting nay: None. Motion carried 9-0.
