

#### **Annual Burnout**

The City of Columbus in conjunction with Public Wholesale Water Supply District #11 will be conducting our annual Water Burnout. Starting on August 9, 2021, and will continue through September 6, 2021, as required by state regulations per the Kansas Dept. of Health & Environment.

The purpose of the burnout is to remove any excess ammonia, bio-films, or nitrification in the water lines. Possible taste and odor problems may occur during this process. Water customers should also be aware that residual traces of ammonia and chlorine must be removed from water prior to use in fish tanks, ponds, and for kidney dialysis. Customers may experience brown, dark, or rusty discoloration of water during this time, however the water is still safe meeting all federal and state requirements.

Thank you all for your help in developing this process. We look forward to meeting with everyone again soon.


