ORDINANCE NO. 1489

A ORDINANCE REPEALING ORDINANCE 1412, ORDINANCE 1413, ORDINANCE 1439, AND ORDINANCE 1487 FOR THE PURPOSE OF RENAMING AND REDEDICATING THE STREET KNOWN AS CROSSLAND LANE TO LAKE STREET.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLUMBUS, KANSAS:

SECTION 1. Ordinance Number 1412 shall be repealed.

SECTION 2. Pursuant to the statutory authority at K.S.A. 12-752, as amended, the Governing Body of the City of Columbus, Kansas, having held a public hearing on January 3, 2022, is hereby authorized to rededicate and rename Crossland Lane to Lake Street, an extension of an existing City street, and to install appropriate signage. Crossland Lane shall no longer exist, and Lake Street shall be devoted to public use based on the express acts and conduct of the previous owner, by deed, and the acceptance of the deed by the Governing Body of the City of Columbus, Cherokee County, Kansas, of the property legally described as follows:

THE EAST - WEST STREET CONNECTING RIVERSIDE AVENUE AND SW 20TH STREET, LOCATED ALONG THE ENTIRE SOUTHERN BOUNDRY OF THE FOLLOWING TRACT: S14, T33, R23, ACRES 9.27, BEG 98.88' S NW COR NW/4 TH ELY 943.3 ELY 252.09 TO NW COR LAKEWOOD WEST PHASE 2 SUBDIVISION SLY 432.83 TO NW COR LOT 14 OF SAID SUBDIVISION NWLY 314.59 W 777.11 N 350 TO POB LESS R/W, CITY OF COLUMBUS, CHEROKEE COUNTY, KANSAS.

SECTION 3. Ordinance Number 1413 shall be repealed.

SECTION 4. Due to the traffic and safety concerns at the intersection of SW 20th Street and Lake Street, as described in SECTION 2, the Governing Body of Columbus, Kansas, directs that a permanent stop sign remain on Lake Street to control westbound traffic at said intersection with SW 20th Street.

SECTION 5. Ordinance Number 1439 shall be repealed.

<u>SECTION 6</u>. Due to ongoing traffic and safety concerns on Lake Street, the Governing Body of Columbus, Kansas, directs that the speed limit on Lake Street, the east-west street connecting North Riverside Drive with SW 20th Street, be maintained at Twenty (20) miles per hour with corresponding signage.

SECTION 7. Ordinance Number 1487 shall be repealed.

SECTION 8. Due to ongoing traffic and safety concerns on Lake Street during soccer seasons, the Governing Body of Columbus, Kansas, directs that traffic on Lake Street shall be one-way, east-to-west, from North Riverside Drive to Twentieth (20th) Street every Saturday morning from 8:00 a.m. until 1:00 p.m. during soccer seasons. The Property and Parks Department shall maintain appropriate one-way signage at both intersections.

SECTION 9. A certified copy of this Ordinance shall be submitted to the Cherokee County Mapping Department in order to update the 911addressing and GIS associated with the name change from Crossland Lane to Lake Street, as described in Section 2.

SECTION 10. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 11. This Ordinance shall take effect and be in force upon passage and shall be published in the official City newspaper.
